DIRECTIONS TO FAITH UMC, COLEMAN.

Coleman is midway between Mt. Pleasant and Midland (20 miles from each) on U.S. 10.

Coming from the East: Go to Rt. 10 by way of 75 or 47, etc. Take it west to exit 103. Continue on N. Coleman Road. Then take N. 6th St. to Jefferson St. The church is 203 Jefferson St.

Coming from the West: Take 127 to Rosebush...Exit 149. Turn on to E. Rosebush Road going east. Go 4.4 miles, then turn left on N. Loomis Road. Go 4 miles and turn right on E. Coleman Road. This becomes W. Shaffer Road, then W. Webster St. and then 7th Street. Turn right onto West Railway, then left onto N. 6th Street. Turn right onto Jefferson. The church is .1 miles on the left. 203 Jefferson St.
